WALK FOR MUSCULAR DYSTROPHY EARLY BIRD CONTEST

THE CONTEST AND THE CONTEST PERIOD

The Walk for Muscular Dystrophy Early Bird Contest ((the "Contest") commences on February 1st, 2011 at 9:00:00 a.m. Eastern Time (ET) and concludes at 9:00:00 p.m. ET exactly 30 days prior to each individual Walk for Muscular Dystrophy scheduled event (the contest period). Example: if the Walk for Muscular Dystrophy event takes place on May 1st, deadline for entry will be at 9:00:00 pm ET on April 1st, 2011.

ELIGIBILITY

The Contest is open to residents of Canada who have reached the age of majority in their province of residence, excluding employees, directors and officers of Muscular Dystrophy Canada and their affiliates, and their respective advertising and promotional agencies, as well as immediate family members of any of the foregoing. "Immediate family member" means parents, sisters, brothers, children and spouse.

HOW TO ENTER AND WIN

No purchase required: Each person that completes the Walk for Muscular Dystrophy registration form online at www.muscle.ca/walk for a location of their preference during the Contest Period including providing their name and email address and all other required fields is automatically given one entry. Only one registration per individual is eligible – multiple event registrations will not apply. All registered registrants prior to the contest commence date will be automatically entered and receive one entry per individual.

DRAWING AND PRIZE

All eligible entries received during the Contest Period will be entered into a random draw to be held in Toronto on or about Tuesday, November 1st, 2011. There is one (1) grand prize. One (1) potential winner will be drawn at random from among all eligible entries.

One (1) Prize will be awarded to the selected entrant once eligibility has been confirmed. Prize must be accepted as awarded and may not be transferred, exchanged and is non-refundable.
